PART I. GENERAL EXPECTATIONS

Riverside Elementary school agrees to implement the following statutory requirements:

- Riverside Elementary school will put into operation programs, activities and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.
